


#### Abstract

#### Abstract

The objective of this research is to contribute to the improvement of the institutional evaluation model now used in HEI, where we collaborate, focusing on institutional self-assessment as an instrument for improving quality through technological resources. Our professional involvement with this theme stems from the experience of three medium-sized private higher education institutions, located in Fortaleza - CE. During these fifteen years, we have lived with activity as an active member of the various Evaluation Committees, both through traditional methods and through the use of new and recent practices. In both cases, many specific peculiarities were observed. However, it was possible to verify that the evaluation in all of them is valued not only as a step in the management process but also as an instrument of improvement and continuous improvement, enabling strategic quality planning. In this research, it focused on the process of institutional self-evaluation seeking to understand both the origin and logic of self-assessment and the contribution of emerging technologies that have become important in this process. According to Laurindo et al. (2001), information technology "evolved from a traditional orientation of administrative support to a strategic role within the organization," allowing the viability of new strategies. It was concluded that the process of institutional self-evaluation with the use of emerging technologies favors the participation of the academic community. It should emphasize that ICTs are endowed with resources that facilitate such engagement, hence the widespread use of email, cell phones, chat rooms, and other tools, providing credibility and transparency, contributing decisively to improving the quality of management processes.





The patients who have the diseases and uses the medicines think that it is a constitucional right having access to new solutions on health. Currently it is possible to realize in a intense way how fast new medicines reach the brazilian health Market wether by health insurances companies liberality or by law decisions. This issue has generated aditional and unplanned cost. This is a retrospective exploratory bibliographic research work and qualitative analysis of data about the Supplementary Health Market, which aims to identify and evaluate the viabitity of the valued based health care models implementations on brazilian Market, specially the risk sharing, which relates medications reimbursement toreslts achieved. The high cost medicines to rare or serious diseases, for exemple oncology medicines have been the target for risk sharing agreements with Strong potential for data generation by prospective analysis or Real world evidences studies in order to direct de medicines to the right patientes. The simplest models of risk sharing agrreements are most promising for private market implementation, as the value proposition best fits the needs of health care providers. On private Market the Risk Sharing Agreements (RSA) may maintain it's character of confidentiality and have it's use expanded as payers and drugs manufacturers increase their mutual confidence besides increase the knowledge in concept as well as improvements on health data infaestructure and results measurement. # Management of a School Hospital: Challenges and Solutions

#### Abstract

This study aimed to verify the perception of employees and managers regarding the effectiveness of the management of a teaching hospital divided between two leaders: one administrative and one academic to achieve better results.

Thus, an exploratory research was conducted, with qualitative and quantitative approach. Data collection took place through a questionnaire applied to the 18 employees of a Veterinary School Hospital and semi-structured interview with their direct manager. It was found that almost 90% of respondents consider the Veterinary Hospital a complex structure, recognize the need for administrative knowledge to assume the management position (95%), understand that administrative issues are resolved in parts of the current management model (72). %), that the hospital manager does not have, or has in part the administrative knowledge necessary to perform the position (44%) and that the delegation of tasks is not done effectively and assertively (61.1%). About the ideal professional to take over management 73% of respondents report that a business administrator and a veterinarian would be ideal. As a result of the interview, it was possible to observe that the management has some difficulties in solving administrative issues and that it considers the figure of an administrator collaborating with the management to be positive, since the two views, the two works complement each other. Therefore, it was possible to highlight the need for an administrator with the clinical management in charge of veterinary hospital management.

#### Abstract

With the passing of the HITECH Act in 2009, healthcare companies in the United States were required to use an application system called the Electronic Health Record (EHR). This led to health service regulation through a series of procedures called the Meaningful Use (MU). This forced physicians who wanted to maintain or start treating patients through Medicare and Medicaid systems to use EHRs. There was a rush for companies to meet this market need and very little time to prepare and test a product with few flaws. In addition, a considerable increase in physician's work, unrelated to their core activity, triggered a crisis in the sector, with most of the professionals reporting suffering from the Burnout Syndrome. This syndrome is characterized by professional discouragement with important consequences. One of them is the impact on the profitability of companies that suffer from low productivity and unexpected expenses related to the change of this professional. Initiatives such as Engagement at Work may be the way out of this crisis.

## Quality of Life of Nurses Who Work in Emergency Units: The Impacts on Care Management

#### Abstract

Objective: Analyze the quality of life of nursing professionals working in emergency units. Method: an exploratory study with a quantitative approach, with 56 nursing professionals from hospitals and UPAS in Salvador / BA, Brazil. A sociodemographic questionnaire was used as an assessment tool for QoL to draw the profile of nursing professionals and the adapted SF-36. For data analysis, Excel Microsoft Corporation and Graphpad prism 8.0 software were used. The results were organized and displayed in tables and figures. Results: It was evidenced that 50% of professionals from the Emergency Care Unit (UPA) reported having regular conditions, while 4.2% who work in the same unit reported having poor and poor working conditions. Regarding the professionals who work in the hospital, 56% infer that they have a good working condition. p-value ≤0.05. It was observed through this study that there is the same percentage of nurses who have moderate and mild pain (33%), manifested in the last four weeks, but 44.2% report that pain interferes little in work activities. Most nursing professionals working in hospitals reported having good health conditions, while professionals working in the UPA reported having a regular health condition, with statistical significance in this data (p=0,9667). Conclusion: The changes observed in our study, particularly in relation to UPA professionals, suggest that they are more subject to stress issues and may cause long-term suffering and illness.

## Healthcare Management and Quality of Life Assessment of Nursing Technicians who Work in Emergency Units: The Relevance in Health Processes

#### Abstract

Aims: To analyze the quality of life (QL) care management of nursing professionals working in emergency units. Method: An exploratory study with a quantitative approach, evaluating 58 nursing technicians from hospitals and emergency units in the city of Salvador, Bahia, Brazil. For data collection, a questionnaire adapted from the SF-36 instrument was used to assess the quality of life of nursing professionals. For data analysis, Microsoft Excel software version 7.0 and Graphpad Prism version 8.0 were used. Results: It was evidenced in the study that 51.7% of nursing professionals report having a regular working condition in their work environment, with 55.1% of professionals working in Emergency Units in Hospitals and 44.9% in Units of Emergency Care consider their health good. It was also observed that 53.5% of nursing technicians experienced moderate pain in the work environment in the last four weeks. Conclusion: An important factor observed in our study that influences the quality of life of nursing technicians is pain. In addition, professionals working in Emergency Care Units who reported having regular health conditions had a worse relationship with care management, demonstrating the importance of management in the quality of life of professionals.



#### Abstract

In order to gain notoriety regarding the transparency of financial and organizational results, Corporate Governance emerged in the business world and its milestone in Brazil was instituted by the Brazilian Institute of Corporate Governance-IBGC, which implemented the Code of Best Practices, used as instruments to foster the objectives of the institutions, solidifying them in the competitive market, promoting advances in the governance standards in the Brazilian legislation. Its premises involve: transparency, equity, accountability and corporate responsibility, as well as contributing to the internal and external public relations. As objective, the research sought to identify the relevance of the implementation of corporate governance, focusing on the transparency of results and reduction of operational and organizational costs in the Distributor of Medicines and Hospital Materials. As a quantitative method, it was used data collection from questionnaires, with nine questions, worked with 62 company employees and as a qualitative form, a bibliographic survey was made that guaranteed the case study of the distributor. As a result, questions one through three showed that about 87.6% of respondents are aware of a company's mission, vision and values. Among questions four to six, the questions about these topics being addressed at the institution were addressed, regarding the employee's understanding, the percentage of respondents reduced to 64.4%. The bibliographic survey allowed the understanding of the questions obtained with the results and thus aggregated information to support the questions. Given the information obtained, about the strategic planning, mission, vision and values of the company, it can be identified that employees had never been introduced to the referred topics at the time of their admission or in information boards of the organization. It is concluded that, because the studied company is of a family nature, it was suggested the implementation of a corporate governance model appropriate to its market mix, elaborating a strategic plan, describing the mission, vision and values of the company, based on Employee research using the SWOT analysis tool, as well as the creation of an internal process audit and the hiring of an independent external audit, in addition to restructuring the organization chart indicated by IBGC, in order to minimize possible failures in administrative operations and financial.





Due to the growing interest in topics related to the financial market, the subject of corporate governance is also gaining prominence in the academic world. In addition, technological advances have relativized geographical barriers, which contributes to the internationalization process of companies. Given the current economic scenario in Brazil, it is possible that conditions may prove even more favorable for the development of the market, which is why this paper intended to contribute to the decision-making process by companies wishing to expand their business internationally and go public. For this, Dunning's Eclectic Paradigm Theory and Myers' Pecking Order Theory were used to analyze the steelmaker Gerdau, a transnational secular company. In the end, it was possible to conclude that the operations carried out by the steelmaker were marked by compliance with the requirements listed in the theories analyzed. Moreover, given the specificities of the contemporary world, corporate governance practices have proven to guarantee the success of the entire process, especially as a result of transparency.

#### Abstract

## Relationship Between Economic Complexity and Social Inequality: A Study of the Brazilian Case

#### Abstract

This work proposes to analyze the relationship between economic complexity and social inequality, if deepened in an analysis of the Brazilian reality. For this, Celso Furtado's concepts of underdevelopment are presented, which allow a better understanding of the Brazilian economic and social scenario of the proposed period. Therefore it's made a contextualization of the Brazilian scenario in the Collor, Itamar, Fernando Henrique, Lula and Dilma governments, briefly assessing each government, its policies, internal and external scenario, economic, social measures and their results. Next, it is analyzed the reduction of income concentration in Brazil during the governments since 1990, from its historical political context and based on data extracted from IPEA, World Inequality Database, among others. Finally, it presents the Theory of Economic Complexity and the relationship made by Hartman et al between the level of economic complexity of a country and its social inequality, using as a base methodology the Big Data analysis by economists Hidalgo and Hausmann to elaborate the Atlas of Economic Complexity (MIT Media Lab and Kennedy School), deepening in some of its concepts such as Product Space, product and region complexity, etc. Thus, it appears that the relief of income concentration in Brazil was largely based on social public policies promoted by governments, and not on a sophistication of the Brazilian productive structure. Thus, it is concluded that the reduction of social inequality in Brazil is not sustainable, since there are no changes in the productive structure of the country, which became less economically complex during the analyzed period.
